- Total tuition (The camp tuition plus a \$15 non-refundable registration fee) is due at the time of registration regardless of absence due to illness, vacations, or any other circumstances.
- There will be no refunds, credits, extensions, or transfers of any tuition after 4/30/10 unless the class is cancelled due to insufficient students. The camp tuition minus \$30 administration fee is refundable by 4/30/10.
- There will be a \$25 charge for each returned check.
- There is a five-minute grace period after camp pickups. Families leaving children at the center for more than five minutes after camp will be charged \$10 for every five minutes beyond the grace period.
