Registration and Enrollment

- Each applicant will be accepted upon submission of a signed Registration Form and an annual non-refundable family registration fee of \$30 with a deposit of two months tuition.
- When enrolling you are automatically enrolled through each semester. Admission to the program is subject to a contractual commitment for the entire semester.

Tuition and Cancellation Terms

- Registration fee is due at the time of enrollment.
- Tuition is due on the first class of each month, regardless of absence due to illness, vacations, or any other circumstances. Late fees are incurred at \$10 per week past due date.
- Students receive 5% discounts when tuition is paid in full at the beginning of each semester.
- Tuition will be prorated for students joining the class mid-semester.
- There will be a \$25 charge for each returned check.
- There are no refunds, credits, extensions, or transfers of any tuition after completion of the first week of the class.
- There is a ten-minute grace period after class for pickups. Families leaving children at the center for more than ten minutes after class will be charged \$10 for every 10 minutes beyond the grace period.
